Information Obligations under Articles 13 and 14 of the GDPR

Under Articles 13 and 14 of the EU General Data Protection Regulation (GDPR), the controller is required to provide the affected data subject with the information specified in these articles. This information sheet fulfils this obligation.

1. Name and Contact Details of the Controller and, if applicable, Their Representatives:

2. Responsibilities for Compliance with the GDPR and the German Federal Data Protection Act (BDSG):

The board of the club is responsible for ensuring compliance with the GDPR and the German Federal Data Protection Act.

3. Purposes for Processing Personal Data:

Personal data is processed for the administration of the membership relationship (e.g. invitations to meetings, collection of membership fees, organisation of sports activities).

Additionally, personal data is transferred to the relevant state sports federations for participation in competitions, tournaments, and league matches.

Furthermore, personal data is published in connection with sporting events, including reporting on such events, on the club's website, in the club's social media presence, and on the websites of relevant sports federations. Personal data may also be shared with local, regional, and national print media.

4. Legal Bases for Processing:

The processing of personal data is generally necessary for the performance of a contract under Article 6(1)(b) GDPR. These contractual relationships primarily include club membership and participation in competitions organised by the relevant sports federations. If personal data is collected without being necessary for contractual performance, processing is based on consent under Article 6(1)(a) in conjunction with Article 7 GDPR.

The publication of personal data on the internet or in print media is carried out in the legitimate interest of the club (Article 6(1)(f) GDPR). The club's legitimate interest lies in informing the public through reporting on the club's activities. As part of this, personal data, including images of participants, may be published in reports on sporting events.

5. Recipients or Categories of Recipients of Personal Data:

Personal data of members who participate in competitions or league matches of state sports federations is transferred to the respective federation for obtaining licences, ranking cards, player passes, or other participation permits.

Bank account details of members are transferred to Volksbank Düsseldorf-Neuss e.G. for the purpose of collecting membership fees.

6. Retention Period for Personal Data or Criteria for Determining Retention:

Personal data is stored for the duration of the membership.

Upon termination of membership, the relevant data categories are retained for a further ten years in accordance with statutory retention periods and are then deleted. During this interim period, the processing of such data is restricted.

Certain data categories are archived for historical documentation of the club's activities. These include first name, surname, team affiliation, significant sporting achievements, and events in which the data subject participated. This storage is based on the club's legitimate interest in preserving a historical record of sporting events, achievements, and team compositions.

7. Rights of the Data Subject:

Under the conditions specified in the GDPR, data subjects have the following rights:

- The right to access under Article 15 GDPR
- The right to rectification under Article 16 GDPR
- The right to erasure under Article 17 GDPR
- The right to restriction of processing under Article 18 GDPR
- The right to data portability under Article 20 GDPR
- The right to object under Article 21 GDPR
- The right to lodge a complaint with a supervisory authority under Article 77 GDPR
- The right to withdraw consent at any time without affecting the lawfulness of processing based on consent before its withdrawal
